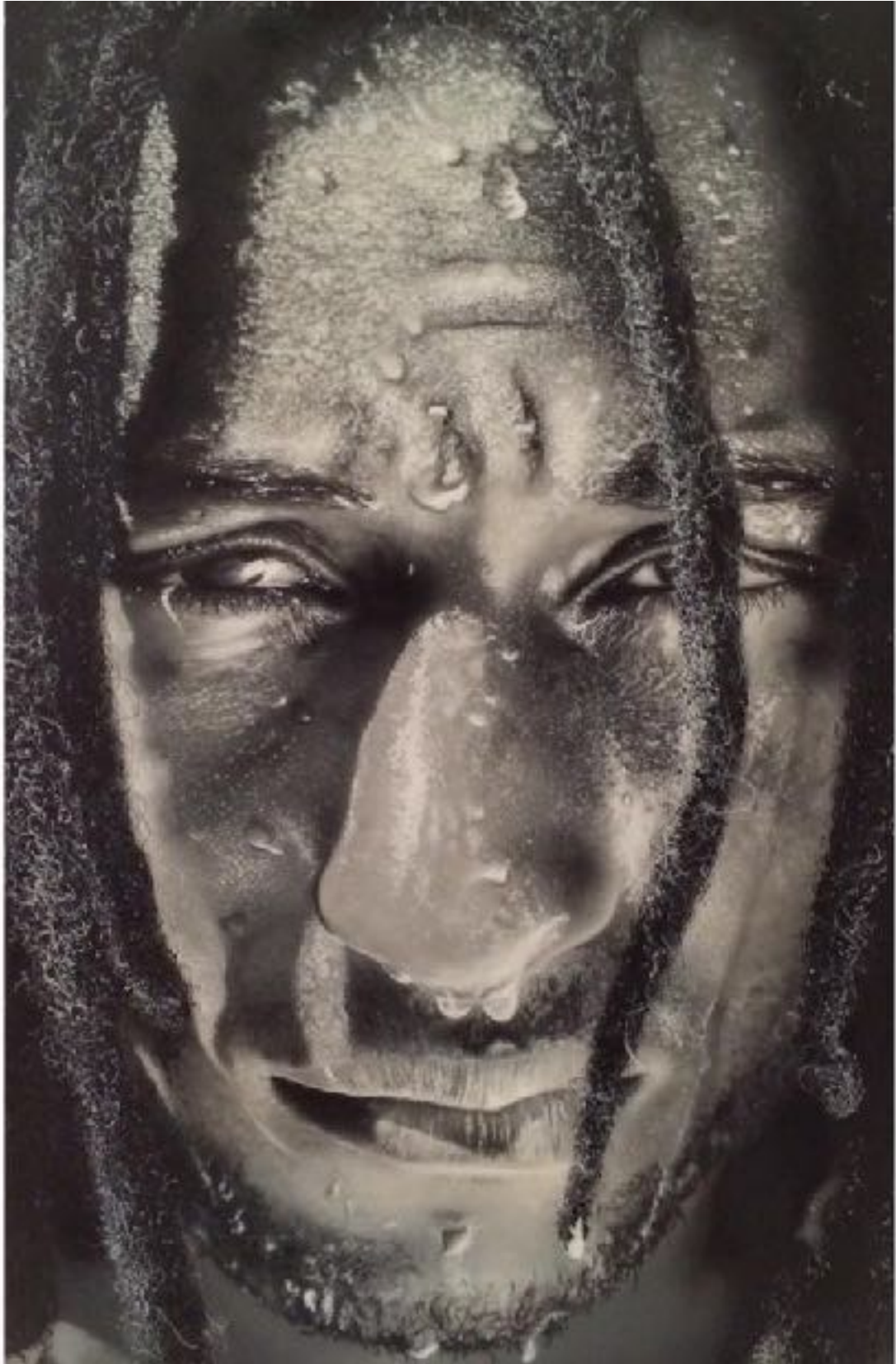
Whilst researching for the Katanning mural project I consistently came across elements of community involvement and multiculturalism.

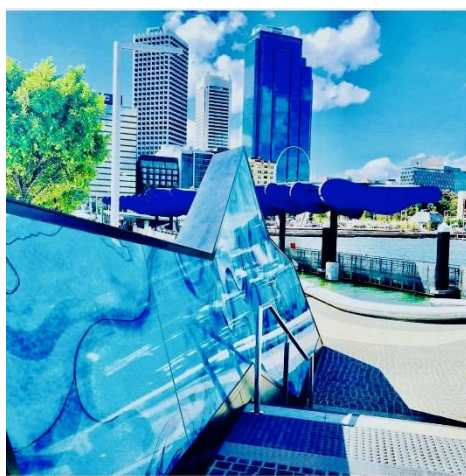
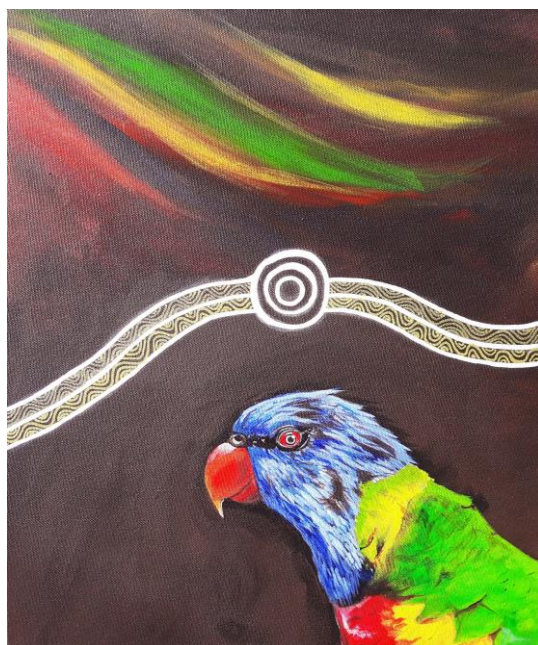
The Western Rosella represents colour and the multicultural Katanning that is now part of the fabric of the township.

Peter Farmer Jnr

Peter Farmer is a Minung Man who's paternal lineage hail from Albany & Gnowangerup regions in the South West of the state. His mother being Ballardong and his father Minung; Peter claims strong connections through his paternal Grandmother's country "Wadjuk", and his birthplace (Subiaco).

Peter is currently completing a Bachelor of Visual Arts at Deakin Uni, Geelong. Peter's father Peter Farmer Snr encouraged him to apply for Public Artworks Commissions; the first awarded to him was in 2015 – Royal Perth Hospital – "Cafeteria Floor".

In 2016 both Peter & Kylie Graham were awarded "Moom Barndi" (Black-Bream) the City of Belmont's new Lookout Park, renamed 'Beliya Kart Boodja' & WINNER of the National Landscape Architectural Award for Cultural Heritage. In early 2017 the City of Cockburn awarded Peter "The New Aquatic Centre" – Aboriginal Sculpture welcoming visitors to the state-of-the-art facility and space. Peter has been fortunate to have shown in a myriad of selected group Exhibition in 2014, 2015 and 2016; and was the only Aboriginal Artist to showcase and exhibit at "Fringe World" All Ages 2017, YMCA, HQ, Leederville, WA.

In 2018 Peter has been awarded two more important Public Art installations, as part of the new branding at the New Perth Airport, and the Royal Perth Hospital's Aboriginal Uniforms for their Aboriginal Liaison Staff; as well as way-finding signage throughout the City complex. In early 2018 Peter was the first Pop-up retail store to launch the "Fill This Space" campaign launched by Activate Perth. "Chirriger Dreaming" and the 'Young Aboriginal Artists Collective' was a success in identifying a need for a more central local 'Aboriginal Arts Gallery' in the City of Perth.

In 2019 Peter was chosen from the best Noongar Artist in the state to install "Worl Waangkiny" "SKY STORIES", Aboriginal Astronomy Project at the Perth Observatory.

Issue:

To consider applications for the 2021/2022 Community Grants Program.

Body/Background:

The Community Grants Program funding was advertised in October 2021 and November 2021 with advertisements in the Great Southern Herald, the Shire of Katanning Website, Shire Matters Newsletter, emails and word-of-mouth to the community and on Facebook.

The Community Grants Program (CGP) provides funding support in three categories; Minor Community Grant (up to \$5000), Major Community Grant (Over \$5000) and Triennium Community Grant (3 year approval- Minor or Major), to enable organizations to develop projects that increase participation and benefit the community.

At the closing date 6 applications were received: 1 application requesting a minor community grant, 4 applications requesting a major community grant and 1 application requesting a triennium grant.

The application process was coordinated by the Community Relations Officer, Natassia Shirazee.

The Community Grants Program for 2020/2021 has \$34,000.00 ex GST available in the budget.

Brief Description of Organisation: Katanning Environmental Inc. operates two successful social enterprises, the Katanning Environmental Nursery and the Katanning Environmental Container Cash In, employing 22 people from within the community, many of whom are CaLD or otherwise under-employed.

Katanning Environmental Inc. are a charity with a purpose of enhancing the natural environment of Australia by promoting sustainability and encourage people to take action through sustainable use of resources. The main focus of the organisation currently includes planting native trees and encouraging recycling.

Project Title: Give Me Shelter

Project Description: Katanning Environmental Inc. currently attends events, such as the Katanning Show, where they sell plants and collect recyclable containers, but currently do not have a branded shade shelter for this purpose.

As Katanning Environmental Inc. has grown, and has become financially independent of Katanning Landcare, they would like to be able to present our organisation at events with a professional image, with our own branded shade shelter.

The 3mx3m 'Summit Classic' marquee from 'Extreme Marquees' will withstand challenging conditions, weather, and transportation, while presenting a professional image for the organisation. This is the same brand and style as purchased by Katanning Landcare over 5 years ago, and is in good condition, despite being in constant use at the Container Cash In facility.

Brief Description of Organisation: Katanning & Districts Pool Association (KDPA) is the recognised incorporated body of eight ball in the Great Southern. The association is affiliated with West Australian Eight Ball Federation and provide an avenue for players wanting to participate in a recreation and competitive pathway.

The Pool Hall provides a venue to not only play 8 ball but to mix socially. This year the Katanning & Districts Pool Association started to run a successful youth 8 ball program with numbers of 28-35 youth. The program is supported by the Shire of Katanning and Katanning Hub CRC with senior players volunteering their time to mentor youth.

The hall is also used by Katanning Home Care Services on a weekly basis and CLONTARF on occasion.

Project Title: Pool Hall Revamp

Project Description: The Pool Hall opened in its current location in the late 80s and the Katanning & Districts Pool Association would like to revamp and improve the current facilities now that it is being used regularly by multiple groups. They have identified improvements to the hall and have separated the project into two stages:

Stage 1:

- Remove current flooring, purchase and install new flooring
- Prepare internal walls for painting and then paint
- Move pool tables around
- Purchase paper towel and soap dispensers and install
- Re-felt pool tables
- Re-hand boards and re-stetting room

Stage 2:

- Removal and installation of new roof (currently asbestos)
- Remove damaged benches
- Purchase storage cupboards and bench top
- Construct and install cupboard and benches
- Connect water and install drainage

This application focuses only on Stage 1 but figures are also provided for Stage 2 for Council information.

Estimated project start date: As soon as funding is approved.

Location of project: Pool Hall, Amherst Street Katanning

Expected project benefits to the community:

- Provide the Katanning community with a clean, updated venue to play pool competitively and socially.
- Provides a venue for a diverse group of men to meet (as large percentage of users are male)
- Upgrades may encourage others to attend.

- Requests to use the pool hall have increased with school groups wanting to use the hall on a regular basis and a better space will benefit the students.

Other community groups and/or key people involved in the project: The project will be managed by Katanning Pool & Districts Association, but the facility is currently used by: Katanning Home Care Services, CLONTARF, Katanning Hub CRC, Baldjamaar Foundation, Katanning Police and Alter One.

Full Organisation Name: Katanning Historical Society

Brief Description of Organisation: The Katanning Historical Society was founded in 1937 and is believed to be the oldest affiliated society in WA. The Katanning Historical Society Museum seeks to collect, preserve, research, document, store or display and interpret items that pertain to the history of the Katanning region from the earlier times to the present.

In addition to normal presentation of significant historical items of interest, the Society welcomes community members and visitors to view these displayed items. They are currently open via appointment.

Project Title: Building Maintenance, Upgrades and Purchase of Display Equipment

Project Description: The Historical Society buildings and grounds are owned by the Shire of Katanning, and they have not had a lot of maintenance carried out on them over the past number of years. The Historical Society now has a new committee with the capability to coordinate and conduct certain maintenance to the buildings itself

Their request will cover the following:

- 1) To carry out maintenance inspections to obtain quotes so future grant funding can be sourced through Lotterywest and other funding opportunities for the ongoing maintenance repairs of the Historical Society buildings;
- 2) To carry out maintenance repairs to the electrical wiring and lighting of the main museum building;
- 3) Replace the roof iron and repair the roof timbers on the main museum building;
- 4) Repaint the exterior of the main museum building;
- 5) Repair and resecure the external weatherboards, strip and repaint the exterior weatherboards of the Band Hall;
- 6) Repair and resecure the external weatherboards, strip and repaint the exterior weatherboards of the Dongolocking School building;
- 7) Installation of fascia and flashing on the ends of the Band Hall;
- 8) Repairs to the leaking roof, replacement of necessary roof sheeting over the anteroom on the old Methodist Church building;
- 9) Completion of perimeter fencing on Richardson St and Install gate; and
- 10) Ongoing purchases of display cabinets, shelving and framing

Estimated project start date: As soon as funding is approved, on-going over a 3-Year period.

Location of project: Katanning Historical Site, Richardson St Katanning

Expected project benefits to the community:

- By making the buildings more secure and safe and presentable to the public
- To assist in the preserving, research, document, store or display and interpret items that pertain to the history of the Katanning region from the earlier times to the present
- To assist in generating community pride and interest in the local history of Katanning and the region



The wearing of a set uniform strengthens community and our school has a demonstrated history of uniform compliance.
