Dear Council,

It has come to our notice that we are placing the staff & volunteers who assist in producing events at the Gallery in dangerous situations. This is due to the outdated and dangerous long platform ladder used to hang exhibit cables from the walls and attach lighting fixtures to the gallery roof.

A solution, in the form of an Elevated Work Platform, has been identified. The Cost of this device is \$8800 (incl. GST).

The Katanning Art Gallery Inc has voted to pledge \$5000 towards the purchase of a Genie GR 15 Mast lift Elevate Work Platform.

We understand that this will become a Shire asset and will be used in the Gallery and Town Hall, and other uses as the Shire sees fit.

Elevated Work Platform Purchase

The Genie GR-15

Due to the unsafe condition of the ladder used in the Katanning Shire's Gallery, an elevated work platform has been identified as an ideal replacement. This machine could also be used in the Town Hall to rig and focus the front-of-house lighting array, and it also has applications at the Katanning Leisure Center.

After much research, the model selected to fit the needs of the three venues is the Genie Roundabout GR-15.



This unit is self-propelled single person platform that will rise to a working height of 6.47 meters. At 975 kg (spread over four rubber wheels) it is unlikely to damage the gallery floor. A safety harness is included free of charge for work beyond 2 meters.

This unit is \$8000.00 plus gst. This is the best deal in Perth. There are cheaper models (such as the GS-1532) and makes for sale, but they are all in the Eastern States and cannot be examined directly (as this one has) and will cost around \$900.00 to \$1200.00 to ship to Katanning.

Also, the GS-1532 weighs in at 1.5 tons. This will almost certainly punch through the cable trench covers that crisscross the gallery floor. But as a scissor style lifter, they are usually around one to two thousand dollars cheaper. But with a lighter (and slightly more expensive) mast lifter, this is not the case.

Certification

An operator license is not required to use this style of platform. A Working at Height certificate is required for any work above 2 meters. This is a four-hour course with a cost of \$200.00 - \$300.00 in Jandakot, Perth






