### Shire of Katanning - Restricted Burning Period

The Restricted Burning Period commences Friday 1 October 2021 for the Shire of Katanning and will be in place until Sunday 31 October 2021.

All burning during this time, including burning of garden refuse requires a 'Permit to Burn' from your local Bushfire Control Officer.

All conditions highlighted on a Permit must be adhered to, if conditions are not met an infringement may be issued under the Bushfires Act.

Your Local Bushfire Control Officer contact details can be located on the Shire Website and in the Fire Requirement Management Notice that is distributed with your Rates or by contacting the Shire on 9821 9999.

### Community Grants Program 2021/2022 Applications Now Open

The Shire of Katanning Community Grants Program (CGP) provides funding support in 2 categories of up to, and over \$5,000 each, to enable the Shire to support projects that promote community capacity, improve social participation and inclusion as well as enhance community harmony and social cohesion.

Each application will be assessed against the following criteria:

1. Does the project:
  - Meet a community need?
  - Benefit a sufficiently broad, or diverse, target group?
  - Align with the Shire of Katanning community vision?
2. Does the organisation have the capacity to undertake and manage the project?
3. Does the application represent value for money?

Collaborative community wide projects are encouraged.

## COUNCIL HIGHLIGHTS

At the August Ordinary Council Meeting for the Shire of Katanning, held on Thursday 23 September 2021, the following items were approved:

### Development Application - Three Grouped Dwellings, Lot 78 (17) Charles Street, Katanning

Council granted Development Approval for Lot 78 (17) Charles Street, Katanning for the purpose of three grouped dwellings, subject to condition.

### Application for Approval to Register Three Dogs

The Shire of Katanning Dog Local Law 1986, as amended 1995 limits the number of dogs kept on any premises to two dogs over the age of three months and the young

of those dogs under that age. That Council pursuant to the provisions of the Dog Act 1976 and the Shire of Katanning Dog Local Law 1986 as amended 1995, approved the application for an exemption to keep three dogs on a property within the Shire of Katanning, subject to conditions.

### Reserve 37629, Katanning Airstrip & 37809 Communication Infrastructure - Modify Management Order to include Power to Lease

Council requests a modification to the Management Orders to include power to Lease or Licence in respect of:

1. Reserve 37629 Lot 600 Katanning-Nyabing Road, Ewlyamartup; and
2. Reserve 37809 Lot 502 Braeside Road, Katanning
